# Laws and Updates

#### **CAN Policy Update**

Watch your email for the new CAN Policy Update, arriving July 17 with a complete look at state legislation impacting nonprofits as the Legislature heads into final 6 weeks of the current session. Of course, one of the biggest issues on the agenda is the state budget and one of the biggest questions facing nonprofits is getting paid while state officials struggle with the state's \$15 billion general fund deficit.

The state's 2008-09 fiscal year began July 1 with no budget in sight. Legislative leaders and some Senate committees are meeting. But things are moving slowly enough that the Assembly has recessed until July 14, though its members are required to be no more than three hours away from the State Capitol just in case there's a breakthrough.

In the meantime, hundreds, if not thousands, of nonprofits are facing the prospect of long delays in payments for services already rendered and left wondering if their state contracts will be renewed and, most importantly, funded. #### Cell phone driving rules

July also means the start of a state-wide ban on talking on cell phones while driving, unless they involve a hands-free device, and a complete ban on cell phone use for drivers under the age of 18 while driving (hands-free device or not). Click here to learn more.

# Nonprofit Career Info

As promised, here's your information on nonprofit careers:

Did you know that the average American now works 1,978 hours per year, compared with 1,942 hours in 1990. That's an increase of almost an entire work week! The average Canadian or Australian or Japanese worker works about 100 fewer hours, and the average German works about 500 fewer hours per year, or 12 and a half weeks less than his or her American counterpart. To learn more about this trend and others, check out this great six-part series from onPhilanthropy: Philanthropy and a Changing World, Tracking the American Economy, An Aging Population Leans on the Arm of Its New Immigrants, Post Industrial America: Changing Social Structure, Enduring Opportunity, Employment and America's Future: Facing the Educational Facts, and Future Public Expectations for American Philanthropy.

Unemployment is remaining <u>fairly constant</u>, but competition for strong candidates remains high. Are you doing all you can do to market your nonprofit? Here's a great piece from Guidestar on Communicating Your Organization's Culture to Job Candidates.

Still not finding the people you want? There's also an interesting resource from American Express's Open for Small Business available <u>online here</u>.

As always, check out the <u>CAN Career Center</u> for California nonprofit job postings – CAN members even get a posting discount! Whether you're looking to hire or looking to be hired, most people know the big three: <u>Idealist.org</u>, <u>The Philanthropy News Digest</u> and <u>The Chronicle of Philanthropy</u>, but are you also making use of more specific sites such as <u>ExecSearches</u>, <u>MediaBistro</u> and the <u>Association of Fundraising Professionals</u>?

And of course, with gas and food prices continuing to increase, it's important to look at employee compensation. The Center for Nonprofit Management has just released its Compensation & Benefits Survey for 2008, available in two region-specific reports (Northern California and Southern & Central California.): <a href="http://www.cnmsocal.org/Services/CompBenSurvey.html">http://www.cnmsocal.org/Services/CompBenSurvey.html</a>. Although the costs for nonprofits are dependent on budget size, access to single job titles is available for \$10-\$30 each. Speaking of job titles, SimplyHired.com, a job search engine, provides handy charts on the direction of employment nationwide based on online job ads. And of course, it's not just enough to hire people — you also need to make sure they have the resources and training necessary. A study released at the beginning of July suggests that three quarters of new managers <a href="mailto:don't know how to manage">don't know how to manage</a>.

The free <u>nonprofit Micro e-MBA program</u> online offers useful modules for everything from starting a nonprofit to working with a board of Directors. <u>Module 4: Basic Skills in Leadership and Management</u> and <u>Managing Ethics in the Workplace</u> can help your managers gain the skills needed for success.

Is your organization just getting started or are you looking to revamp your job descriptions, HR materials or just your office forms in general? The National Council of Nonprofit Associations (NCNA) has a great collection of forms, polices and job descriptions for nonprofits. Materials can be duplicated by charitable organizations with attribution to the NCNA. You can also find a comprehensive one-stop shop for HR materials ranging from employment law to administration and technology available here.

And finally, for new grads and those who are still struggling to figure out insurance and retirement and taxes, here's a <u>helpful article</u> that explains a bit of everything.
